

## OFFICIAL RULES

### The Peanuts Movie Sweepstakes

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.

ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF ENTRIES RECEIVED AND QUALITY OF SUBMISSIONS. VOID WHERE PROHIBITED BY LAW.

BY ENTERING THE SWEEPSTAKES, YOU, ("PARTICIPANT") AGREE TO THESE OFFICIAL RULES, WHICH FORM A CONTRACT. WITHOUT LIMITATION, THIS CONTRACT INCLUDES INDEMNITY OBLIGATIONS ON THE PART OF PARTICIPANT AND A LIMITATION OF PARTICIPANT'S RIGHTS AND REMEDIES.

1. **ELIGIBILITY:** The Peanuts Movie Sweepstakes ("Sweepstakes") is open to legal residents of the fifty (50) United States and the District of Columbia, who are the age of majority in their state of residence at the time of entry. Persons in any of the following categories are NOT eligible to win a prize: (a) employees or agents of Sponsor and Administrator and their parent companies, subsidiaries, affiliates, advertising and Sweepstakes agencies, (b) individuals engaged in the development, production or distribution of materials for the Sweepstakes; and (c) persons who are in the immediate family of any person in any of the preceding categories (including mother, father, sister, brother, daughter, son, spouse, grandmother, grandfather, children or grandchildren), regardless of where they live; or persons who reside in the same household, whether related or not, as any person in any of the preceding categories. 2. **PROMOTION PERIOD:** The Sweepstakes begins on or about 12 noon Central Time on October 22nd, 2015 and ends at 12 noon Central Time on November 22nd, 2015 ("Promotional Period"). Administrator's computer is the official time-keeping device for the Sweepstakes.

There are two (2) methods of entry.

3. **HOW TO ENTER:** If you are not already a member of Facebook, you can create an account at [www.facebook.com](http://www.facebook.com); creating an account is free. Once you have a Facebook account, locate the application on the Club Tyson fan page. Click on The Peanuts Movie icon located in the favorites tab, where users will be automatically directed to the application page. Entrants will be given the option here to enter via two methods. They may enter by clicking on "Skip the game and enter for a chance to win" and entering their email address. The second method of entry is to continue to play the puzzle slide game, by connecting via

Facebook connect. The maximum number of entries that an entrant can possibly receive for the sweepstakes is three (3). One entry if the user decides to skip the game and enter via email; two entries if the user completes the puzzle slide game with an additional optional entry for sharing the game via Facebook. Multiple participants are not permitted to share the same Facebook profile. Any attempt by any Participant to obtain more than the stated number of entries by using multiple/different profiles, identities, registrations and logins, or any other methods will void that Participant's entries and that Participant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the Facebook profile used to register will be deemed to be the registrant. The authorized account holder is the natural person assigned an email address connected with the Facebook profile by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Each potential winner may be required to show proof of being the authorized account holder.

**TO ENTER BY EMAIL:** Send an email to [contests@clubtyson.com](mailto:contests@clubtyson.com) with the subject line "The Peanuts Movie Sweepstakes" with your full name, full street address (no post office boxes allowed), and phone number (including area code) and a statement that Participant is the legal age of majority in the state in which they reside as of the date of entry. Participants that submit an entry via e-mail are subject to all entry limitations specified above, including limitations of one (1) entry without playing the puzzle game.

4. **PRIZE DRAWINGS:** On or about November 23rd, 2015, the first place, second place and third place prize winners will be randomly selected from among all eligible entries received during the Promotion Period. Drawing will be conducted by Administrator, whose decisions will be final on all matters relating to this Sweepstakes. Administrator has developed a random selection application to determine the winner. Selection of the potential winners is determined by Administrator and its proprietary code. Administrator's selection of a winner is final and binding in all matters related to the Sweepstakes. Potential winners will be randomly selected and, if participating via Facebook, will be contacted via email for prize fulfillment. Participants who submit an entry via e-mail will be notified of a potential prize via e-mail. If Administrator is unable to contact potential winner within a reasonable time period, prize or prize notification is returned as undeliverable or potential winner is not in compliance with these Official Rules, any potential prize will be forfeited. Prizes valued over \$600.00 U.S. Dollars will require winners to provide a valid social security number with the release. Internet access and printer required, and must bring printed certificate to the participating theater box office to redeem. Not valid with any other offer.
